Introduction and aim

Periam & Williamson Ltd is an electrical contracting business, operating from a site in Boston, Lincolnshire. We carry out a varied amount of electrical works in domestic, Industrial and commercial environments. We recognise that our operations result in the generation of some waste. It is our aim to continue to reduce the environmental impacts of our business and operate in an environmentally responsible manner. This policy describes how we will achieve our aim.

Responsibility

This environmental policy applies to all of our operations including management, office services, printing, delivery and procurement. Richard Cozens is responsible for ensuring that the policy is implemented. However, all employees have a responsibility in their area to ensure that the aims and objectives of the policy are met.

Resources

We will ensure that resources are available to enable us to achieve our objectives and targets.

Objectives

- Continue with our current waste system of recycling using R Reids Ltd for lamps of all types. These lamps are to be returned to R Reids without the cardboard covers to recycling. A copy of their licence is available.
- To maintain our commitment of not having waste go to land fill by using Mountains skips who maintain a policy of 100% of their waste being recycled or re-used, non going to land fill. A copy of their certificate is available.
- To return all cable drums for pickup by wholesalers for reuse.
- inform all customers and suppliers of our commitment to reducing our environmental impact

Targets

To achieve our aims, we have set ourselves the following targets:

- inform all customers and suppliers about our environmental policy by placing our policy on our website
- Ensure all employees receive training in good housekeeping and incorporate this training into the induction programme for new starters as part of their apprenticeships
- Ensure that all employees send any waste we generate to either R Reids for disposal or placed in our skip for environmental recycling.
- To make customers aware that waste removed from their own equipment is their responsibility and they source where ever practical ways to dispose of this waste and reducing the impact on the environment.

Monitoring and auditing

Progress against these objectives will be monitored through annual management meetings.
